6. HOW WILL THE HILL COMPANY USE THE PERSONAL DATA IT COLLECTS ABOUT ME?

The Hill Company will process (collect, store and use) the information you provide in a manner compatible with the EU's General Data Protection Regulation (GDPR). We will endeavor to keep your information accurate and up to date and not keep it for longer than is necessary.
